

**AGREEMENT (M.TECH Programme)**

AND WHEREAS if the student who obtain admission and discontinues his / her study due to any reason including the instance that he / she fails to qualify in the prescribed qualifying degree examination with Percentage as prescribed in the prospectus of Directorate of Technical Education, the First PARTY is liable to pay the tuition fees and special fees for whole of the programme amounting to Rs 266000/- plus Rs. 30000/-, ie, Rs 296000/- (Rupees Two lakh ninety-six thousand only) as liquidated damages for the remaining period of the course, subject to the amount already paid against the said course fee (of Rs 66500/-) and that the Transfer Certificate be issued only on full and final settlement of the said dues.

NOW, THEREFORE, I / WE ..... Student and ..... Parent / Legal Guardian offer myself / ourselves as surety for the said sum of Rs 296000/- (Rupees Two lakh ninety-six thousand only) subject to the amount already paid against the said programme fee, in the event of the student violates any of the terms and conditions contained aforesaid and upon a Notice of such violation being issued to me / us. I / We, therefore, further agree and promise that if I / We fail in making such payments, the Second Party may realize the entire aforesaid sum due to the Second Party from me / us and / or from my / our properties both movable and immovable as per the applicable laws of land at the discretion of the Second Party.

PROVIDED THAT my / our liabilities as surety under the bond shall be limited to a total sum of Rs 296000/- (Rupees Two lakhs ninety-six thousand only) subject to the amount already paid against the said sum.
